

## **2021 Workforce Housing Development Program Scores**

The Workforce Housing Development Program (the "Program") is a competitive funding program that targets small-to medium-sized communities in Greater Minnesota with rental workforce housing needs. Funding is available to build market rate residential rental properties in communities with proven job growth and demand for workforce rental housing. The applications in the below chart were submitted to the 2021 Workforce Housing Development Program's Request for Proposals that was due on Tuesday January 11, 2022. After Minnesota Housing staff and community reviewers finalized project scores and verified project feasibility, scores were incorporated into the final funding recommendation and presented to the selection committee. Projects were then recommended for approval by Minnesota Housing's board members based on eligibility, final score, and available funding. Minnesota Housing Board made the selections at their meeting on April 21, 2022. This information is provided in accordance with Minn. Stat.§462A.24.
