# Start Up Program Targeted Area Census Tracts

Targeted Areas consist of certain census tracts in the state in which 70% of the families have an annual income of 80% or less of the statewide median income, or areas determined by the State and approved by the Secretary of the Treasury of the United States and the Secretary of the United States Department of Housing and Urban Development to be areas of chronic economic distress.

## Notice of Mortgage Funds Available

Minnesota Housing is setting funds aside to make mortgage loans to first time home buyers in certain census tracts located in the following counties: Beltrami, Benton, Blue Earth, Cass, Clay, Crow Wing, Freeborn, Goodhue, Hennepin, Itasca, Lyon, Mower, Nobles, Olmsted, Ramsey, Stearns, St. Louis and Todd. Borrowers and properties must meet Minnesota Housing's maximum income and purchase price limits as well as normal, mortgage industry accepted underwriting requirements. #### **Properties in a Targeted Area**

A property located in a Targeted Area has a higher income limit to trigger the subsidy recapture tax.

#### Determining if a Property is Located in a Targeted Area

For Lenders generating documents from the Minnesota Housing Commitment System:

• The Minnesota Housing Commitment System will determine if the property is in a targeted or non-targeted area and automatically populate the Subsidy Recapture form.

For Lenders **not** generating documents from the Minnesota Housing Commitment System:

- Use the <u>interactive map</u> to determine if a property is in a targeted or non-targeted area.
- If the property is in a Targeted Area, make sure the box on page three of the <u>Start Up Subsidy</u> <u>Recapture Statement and Tennessen Warning</u> is checked. If the box remains unchecked, the form defaults to Non-Targeted Area.


