

2024 Workforce Housing Development Program Request for Proposals: Selection Framework and Final Scores

Last Updated: October 2024

Overview

The Workforce Housing Development Program (WHDP) targets small-to medium-sized communities in Greater Minnesota with rental workforce housing needs. Funding is available to build market rate residential rental properties in communities with proven job growth and demand for workforce rental housing. WHDP funds are administered through a competitive Request for Proposes (RFP) process.

Selection Framework

The WHDP is governed by requirements set by statute, rules, and the <u>WHDP Program Guide</u>, which outline a variety of preferences, priorities, and requirements for projects that are selected for funding. Additional details may be found in the <u>WHDP RFP Application Instructions</u>.

Non-Select Criteria

An application may be determined ineligible or non-select due to one or more of the following criteria:

- Statutory or threshold requirements
- Project feasibility
- Geographic distribution
- Underwriting standards
- Amount of funding requested
- Development cost
- Statutory preference

Minnesota Housing was able to select 56% of submitted applications with the funding available through the 2024 WHDP RFP. Insufficient resources is the primary reason that an application is not selected.

All non-select applicants may meet with Minnesota Housing to receive a debrief on their application. Minnesota Housing also offers technical assistance to provide applicants guidance on submitting a competitive application including feedback on underwriting, scoring, project feasibility, and other specific areas.
