

2024 Publicly Owned Housing Program Scores

The Publicly Owned Housing Program (POHP) is a competitive funding program that uses the proceeds of General Obligation (GO) Bonds to provide financing in the form of a 20-year deferred, forgivable loan for the rehabilitation and preservation of public housing. Additional information about POHP can be found in the POHP Program Guide POHP Program Guide (mnhousing.gov).

The applications in Table 1 were submitted to the 2024 POHP Request for Proposals (RFP) that was due March 6, 2024. After Minnesota Housing staff finalized project scores and verified project feasibility, scores were incorporated into the final funding recommendation and presented to Minnesota Housing's selection committee. Projects were then recommended for approval by Minnesota Housing's board members based on eligibility, final score, immediacy of need, geographic balance, and available funding. Minnesota Housing's board members made the selections at their meeting on June 27, 2024. This information is provided in accordance with Minnesota Statute 462A.24.
