



## **Family Homeless Prevention and Assistance Program (FHPAP) Client Reference List: FY2026 – 2027**

The Family Homeless Prevention and Assistance Program (FHPAP) provides temporary supportive services and financial assistance to eligible households experiencing a housing crisis. Regional FHPAP providers are available to support all household types in stabilizing their housing situation as quickly as possible.

Services are provided to households that are:

- At-risk of homelessness (referred to as Prevention)
- Currently experiencing homelessness (referred to as Rapid Rehousing)

Households are further distinguished by household type:

- Adult Single or Family
- Youth (18-24) Single or Family
- All
