Minnesota Housing Finance Agency (the “Agency”) issued its Residential Housing Finance Bonds, 2025 Series B (Taxable) (CUSIP 60416UPF6*) (the “Bonds”), as variable rate demand bonds on February 20, 2025. On that same date the Agency entered into a Standby Bond Purchase Agreement, dated as of February 20, 2025 (the “Standby Bond Purchase Agreement”), between the Agency, Computershare Trust Company, National Association, as trustee and tender agent, and Federal Home Loan Bank of Des Moines, to provide liquidity support for the Bonds in accordance with its terms.

A copy of the Standby Bond Purchase Agreement has been filed on EMMA under the CUSIP shown above for the Bonds.
